### **Conservation Programs Technician (Seasonal / Temporary)**



Jordan Valley Water Conservancy District is seeking individuals to assist with water conservation programs and public engagement activities.

**Job Summary:** Excellent learning opportunity for individuals interested in water conservation, environmental science, sustainable landscaping, and related fields. As a seasonal Conservation Programs Technician, you will support the implementation of water conservation programs by assisting Conservation Coordinators with rebate processing, landscape measurements, and participant consultations. The role includes field work to verify program compliance, evaluate water-wise landscaping and irrigation components, and support education on water conservation

principles, irrigation systems, and appropriate plant selection and design principles.

This position includes a mix of field and office work, generally split approximately 60 percent field and 40 percent office, though proportions may vary. Field duties include assisting with off-site visits to yards and outdoor landscapes to support program implementation, including project measurements, evaluation of landscape and irrigation components, compliance verification, and participant education. Office duties include customer service focused on troubleshooting issues and helping participants successfully complete program requirements, assisting community members with program inquiries and applications, data entry, and mapping project areas. The role may also include gathering photo and video content to support program communications and social media outreach. Regular travel between off-site locations using District vehicles is required as part of field-based responsibilities. May assist with other conservation programs and perform other duties as assigned.

**Job Requirements:** A minimum of two years of college coursework in natural resources, conservation, environmental science, horticulture, landscape management, plant science, landscape design, or a related field is required. A valid driver's license is required. Candidates must be proficient in Microsoft Office applications and demonstrate strong time management, attention to detail, and accurate data entry skills. Strong customer service skills and the ability to work both independently and as part of a team are required. Must be comfortable working outdoors in a variety of weather conditions. A genuine passion for water conservation and sustainable practices is highly valued.

**Wage:** \$18 per hour

**Hours:** Full-time positions, 40 hours/week, from March through October. Must be able to work Monday through Friday, excluding holidays. May be required to work an occasional weekend event.
