helping staff to implement their duties. The natural resource program is part of Environmental Resource Management for the Utah National Guard.

This position will be part-time (20 hours/week) during the school year and full-time (40 hours/week) over the summer. Preferably all hours, but at least 10 hours must be worked M-Th 0600- 1800. Summer hours are 4-10 hour days M-Th. Position may end at the end of the federal fiscal year (September 30, 2020) but will not exceed past two years. The successful candidate will report to the Natural Resource Manager.

Principle Duties

- Assist staff in executing projects, including contracting, overseeing work, monitoring and reporting. Projects may include planting, reseeding, thinning and other vegetation treatments.
- Collecting data for NEPA (National Environmental Policy Act) analysis for military training and support activities throughout Utah.
- Assist with development and writing of plans and reports.
- Assist with meetings as needed.
- Assist staff with development and execution of field surveys, including substituting in various field crews.
- Design and monitoring of wildfires and follow-up for past projects.
- Assist with other natural resource management and monitoring as required.

Required Qualifications

- Majoring and intending to have a career in natural resource or environmental field, such as range management, environmental science, wildlife, conservation biology, with at least 4 environmental or science classes.
- Familiarity with Windows computers.
- Basic familiarity with Trimble (or other) GPS and ArcGIS.
- Knowledge of Microsoft Word and Excel.
- Good writing and editing skills.
- Good interpersonal skills.
- Able to work in hot or cold, wet or dry environmental conditions in densely vegetated, steep, rocky terrain.
- Utah Driver License.

Preferred Qualifications

- Positive view of the national guard or other military.
- Familiarity with the Utah National Guard's environmental programs and regulations.
- Familiarity with federal and state environmental laws.
- Familiarity with NEPA requirements.
- Basic familiarity with Endangered Species Act and any corresponding State of Utah requirements.
